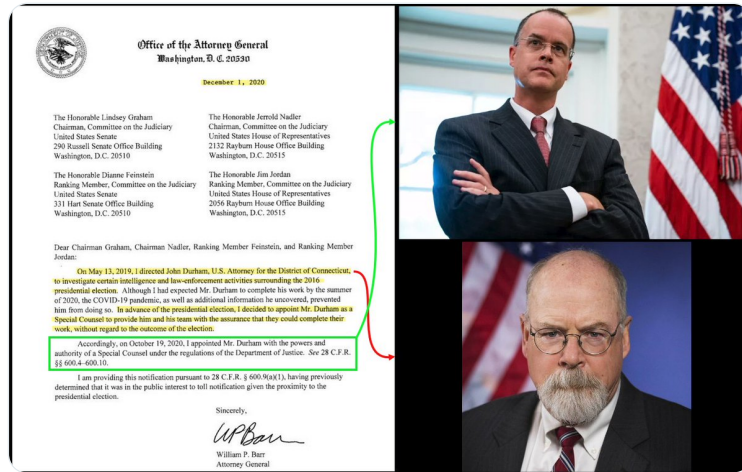

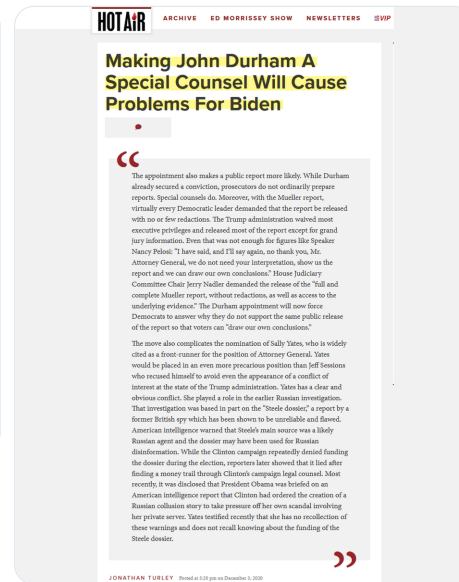



In a memorandum of May 23, 2019, I directed the heads of elements of the intelligence community, as defined in 50 U.S.C. 3603(i), and the heads of each department or agency that includes an element of the intelligence community to assist the Attorney General in connection with that review, and authorized the Attorney General to declassify, downgrade, or direct the declassification or downgrading of information or intelligence that relates to his review. In addition, the Attorney General is authorized to use classified information as he deems necessary in connection with his review, including in a grand jury or other proceeding.

Sec. 2. General Provisions. (a) Nothing in this memorandum shall be construed to impede or otherwise affect:

- (i) the authority granted by law to an executive department or agency, or the head thereof; or
- (ii) the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.


(b) This memorandum shall be implemented consistent with applicable law and subject to the availability of appropriations.

(c) The authority in this memorandum shall terminate upon the conclusion of the Special Counsel's investigation, unless expressly extended by the President. In addition, the authority of the Attorney General under the May 23, 2019, memorandum is hereby extended to terminate only upon the conclusion of the Special Counsel's investigation, unless expressly extended by the President.

(d) This memorandum is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, or entities, its officers, employees, or agents, or any other persons.

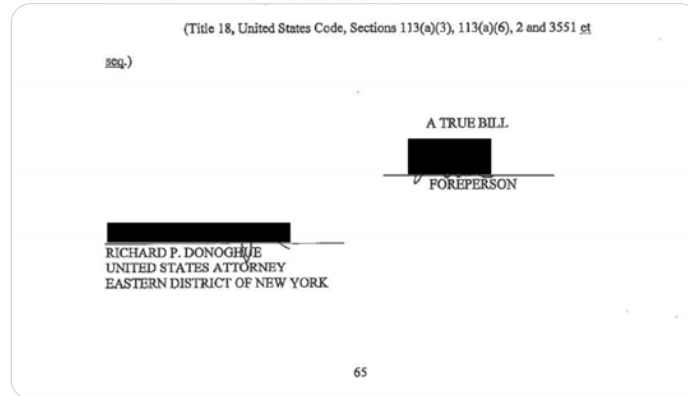
